Work plan

The Committee's last two work plans focused on two key areas: revitalizing the Committee and studying specific themes. Measures have been taken to revitalize the Committee's work: a list of members was developed, rapporteurs and vice-presidents were appointed, and partnerships were formed. As well, the studies on the themes «Child Mortality», «Water, Health and Poverty» and «Chronic Diseases» were completed.

To continue the work that has been started, under this work plan the Committee will pursue the same two focus areas the previous periods. As such, the Committee's objectives for 2015-2016 will be as follows:

- 1) Consolidate the measures aimed at revitalizing the Committee's work; and
- 2) Pursue the in-depth study of the themes in conjunction with the rapporteurs.

1. Consolidating measures aimed at revitalizing the Committee's work

- Consolidate the list of Committee members;
- Identify the respective duties of each member of the board;
- Follow up on progress on the themes the Committee is studying;
- Maintain the partnership initiated with the Pan American Health Organization (PAHO) and create partnerships with other international organizations for support in studying the themes.

2. Themes

- a. Pursuing the "Integration of public health policies in the Americas" theme
- Presentation by an expert;
- Presentation of a declaration.

b. New study themes:

- 1) Cancer in the Americas
- 2) Prevention of nutrition of unborn children and the fight against malnutrition; By MP Marcelo Daniel Rivera.
